Declaration of conformity according to California Proposition 65

The regulation „Safe Drinking Water and Toxic Enforcement Act“ of 1986, also known as California Proposition 65, contains a list of chemicals notoriously known to the state of California to cause cancer, congenital defects or reproductive damage.

The list consists of approximately 800 chemicals and is released and updated annually by the Office of Environmental Health Hazard Assessment (OEHHA).

This certifies that W. Köpp GmbH & Co. KG does not intentionally use or add any chemical substances listed in the current California Proposition 65 regulation when manufacturing its current foam products. Exceptions to this are our FR grades and certain sponge rubber compounds, which may contain the following substances:

- Antimon trioxide (Sb_2O_3 , CAS: 1309-64-4).
- Diisononyl phthalate (DINP, CAS: 28553-12-0).

Antimony trioxide is used as a flame retardant in the FR-qualities K/PE35FR and K/PE45FR from the section of cellular polyethylene. An alternative provides the HFFR-qualities based on halogen-free flame-retardant systems.

Some sponge rubber mixtures – such as chloroprene rubber (CR) based, acrylonitrile butadiene rubber (NBR) based and hydrated acrylonitrile butadiene rubber (HNBR) based mixtures – contain diisononyl phthalate (DINP) as plasticizer. Sponge rubber mixtures without this chemical are covered by our portfolio.
